NOTES TO THE FINANCIAL STATEMENTS

- 1) Balance Sheet The District holds \$2,894,991 more in cash than last year.
- 2) Some accrual items on the Balance Sheet have changed since last year as we are currently under audit. Expect a report from our Auditors at the next Board Meeting on March 24th.
- 3) On March 1st we will have an interest payment on the Bond Debt of \$1,200. Our last payment of P&I of \$81,200 will be on September 1, 2025 dissolving the debt.
- 4) Revenue & Expense January 2025 only. 410 Property Tax collection was higher than in past years. As of January 31st, we have collected 89% of the current tax levy. 600 Emergency Response is elevated due to the purchase of nine portable radios for a total of \$92,000. 650 Administration for last year had an expense of \$63K regarding the Long-Term Planning Study.
- 5) Revenue & Expense Year to Date has a net revenue of \$1,309,339 greater than that of last year (2x) due to strong Property Tax collections and TIFMAS reimbursements. Expenses are relatively the same compared to last year.
- 6) Budget vs. Actual for the four months is tracking positive on nearly all accounts.
- 7) Checks over \$2,000. BielsteinIT services are double the expense compared to normal monthly charges. The reason for the increase is due to a replacement of a lost/stopped check payment in October. Delta Industrial \$6,240 was for a decontamination unit to clean the air packs. There where two large reimbursements to Fire Academy students that paid their tuition in full, but after the first class decided that being a Firefighter was not for them. Maxwell Locke & Ritter for \$19,000 is for the expected audit fee due upon completion. Travis County Emergency is for fees due for one year on 67 radios at \$398 per unit.

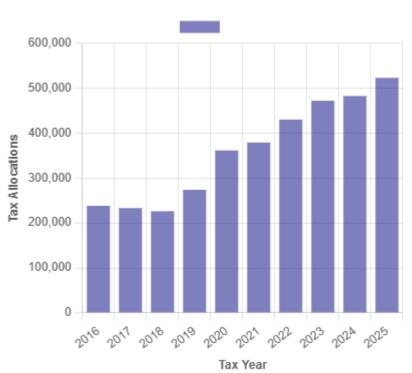
February 2025 Sales Tax Summary

The February allocation reflects sales made during the month of December.

Our February 2025 sales tax allocation was \$522,529 which was up 8.4% (+\$40,322) compared to February 2024 and up 0.2% (+\$5,011) year to date compared to last fiscal year.

Our top 10 large companies accounted for 54.4%, our top 30 large companies accounted for 69.8%, and our top 100 large companies accounted for 83.2% of our total fiscal year to date collections.

Compared to February 2024, a significant increase (58%) occurred with Amazon Marketplace while we experienced a 45% decrease with Vaughan & Sons and a 24% decrease with McCoy's. The Omni Barton Creek Resort was up slightly (7%) from last February.

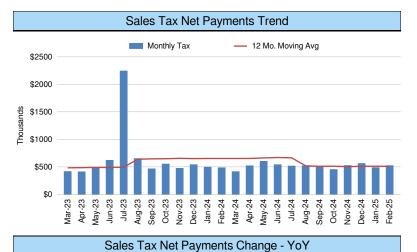

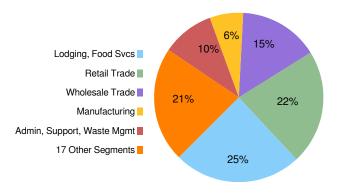

Sales Tax Collections by Industry Segment



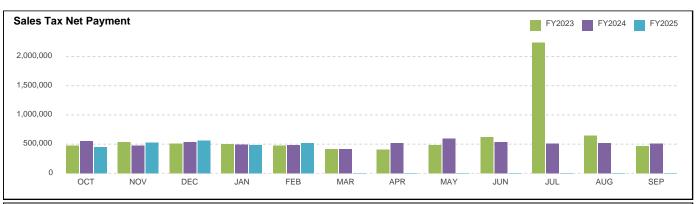

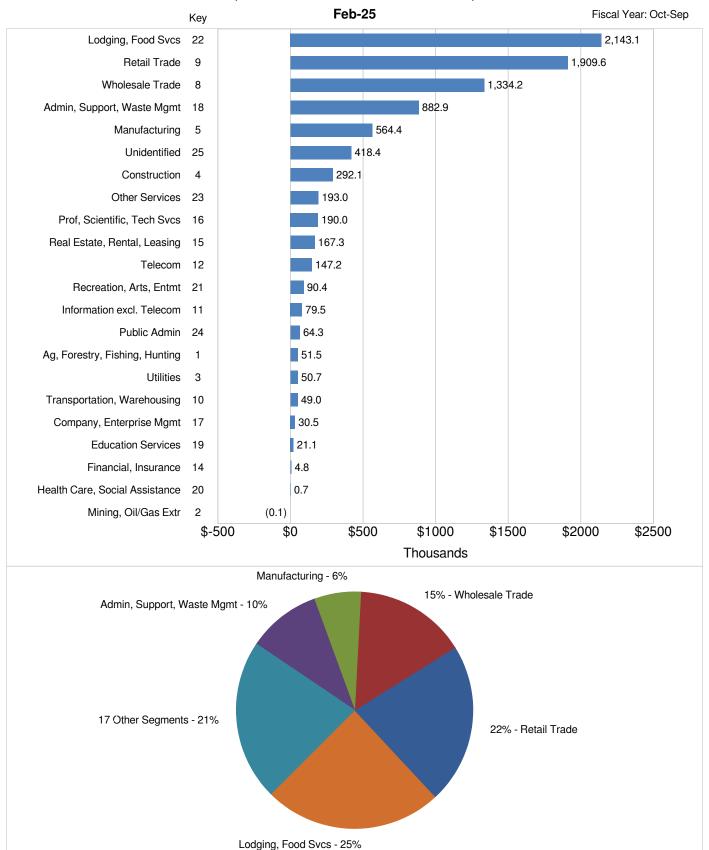

INDUSTRY SEGMENT SALES TAX RANK & DISTRIBUTION

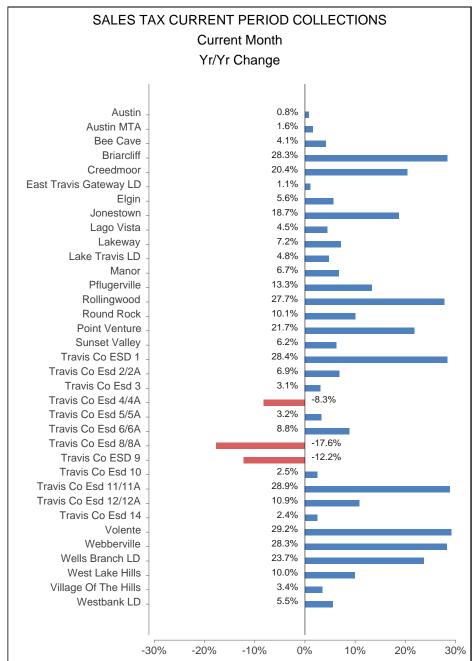

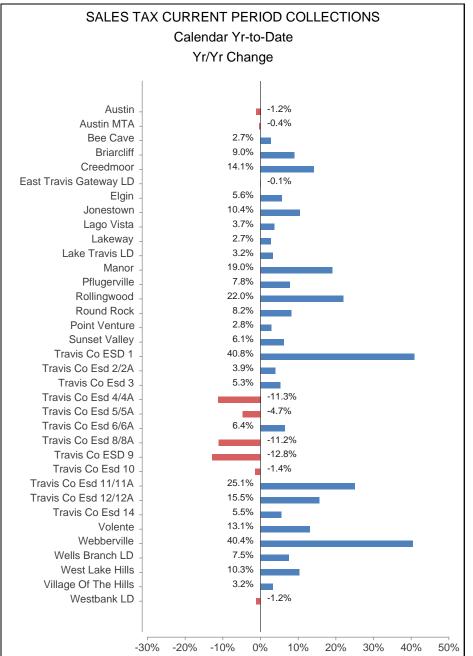






SALES TAX TREND TRAVIS COUNTY Feb-25

February 2025 Operations Report

Significant Events

January 6 (A) – Structure Fire – AutoAid Given (Austin) – 6636 William Cannon Drive #327 [Engine 301] E301 called out for a box alarm. On arrival to be third in engine and first thing we got told was to get E27 on a hydrant. E301 crew then took 5" hose off of E27 and hooked them up to a hydrant. After that, E301 crew was then assigned to R20 to help out with roof operations. E301 crew held the ladder while they were on the roof and also got them a hoseline from E27 to the roof. Once the roof fire was out and it was controlled, E301 crew was then told we could clear the call.

[Truck 302] TK302 arrived as the 2nd truck and met with Command. Command requested that we assist Q51 with opening the wall and ceiling in the 3rd floor breezeway to establish a cutoff line to prevent fire spread between buildings. TK302 accomplished this and was then requested to assist E27 with pulling ceiling in the fire apartment on the 2nd floor. TK302 assisted with that task and did not find any further fire spread. TK302 remained on scene for further assignment and then the fire was declared under control. Command cleared TK302 shortly after. TK302 gathered all equipment, cleared, and returned into service.

[Battalion 301] BAT301 arrived on scene and met up with BAT08 (Incident Commander). There was a fire in the attic of a two-story apartment building next to the chimney. I assisted with water supply for E27. IC requested that I coordinate the evacuation of the building, so I met with APD and they assisted with this. I then let IC know the evacuation was completed. After that task was completed, I assisted the IC with management. The crews had the majority of the fire knocked down and units were opening up the ceiling and walls to check for extension. We had a crew go to the roof as we had fire that was coming out of the roof. The crew went up and opened up the roof and then requested a hoseline as they had a few spots that needed a little water for embers. They also opened up the chimney on the Charlie side to make sure there wasn't any hidden fire. The IC then called the fire under control and started to release units. There were six people displaced due to the fire and were relocated to a different apartment for the time being. All Oak Hill units were released from the scene and went back into service.

January 6 (B) – Structure Fire – 8005 Williamson Creek Dr

[Engine 301] On the morning of 1/6/25, the resident of 8005 Williamson Creek Dr. called Station 302 to report that his stove had caught on fire. He thought that the fire was out but wanted us to stop by and check. BC Patton called Station 301 and asked us to go over there. E301 radioed Fire Dispatch and asked them to create a call for a 'Public Assist' at 8005 Williamson Creek. E301 arrived at a one-story single-family residence and met with the resident. E301 went into the kitchen and saw a burnt-out stove with no evidence of active fire. The stove and a microwave mounted above it were both badly burned, but it did not look like the wall or ceiling were affected. The resident stated that he thought the fire had been started by wiring that had been damaged by rats. We checked around the stove with a TIC, then went into the adjoining room and checked the backside of the wall the stove was on. We also turned off the breaker marked 'stove' in the breaker box. E301 then cleared from the call.

January 7 (B) – Hi-Rise Structure Fire – AutoAid Given (Lake Travis) – 12325 Carlsbad Drive [Truck 302] TK302 arrived on the scene and established Outside Division. TK302 conducted a face-to-face meeting with the Incident Commander; the IC had TK302 size up the Charlie and Delta sides. TK302 reported fast-moving smoke coming from the eaves. TK302 placed a 24-foot ladder on the Charlie side of the structure and a 35-foot ladder on the Delta side. IC had TK302 move the ladder from the Delta side to the Bravo side. TK302 assisted the Inside Division with making roof access on the Charlie side deck to extinguish hotspots on the roof near the chimney. IC placed TK302 on deck to replace interior crews. The IC cleared TK302 before being needed inside.

[Battalion 302] BAT302 responded to a structure fire in ESD6. Upon arrival, we had a working fire and BAT302 went to the Command Post. BAT602 had assumed Command and we were in the offensive mode with units on scene and other still enroute. BAT302 assisted BAT602 at the Command Post with tracking units and their assignments. We were on scene for about 20 minutes when the interior crews were able to knock the fire down. Once the fire was knocked down, BAT302 met with the Safety Officer to discuss any potential hazards while the crews were looking for extension and mopping up. BAT302 went back to the Command Post to give the IC an update. Shortly after BAT302 debriefed the IC, the IC cleared BAT302.

<u>January 8 (C) – Structure Fire – AutoAid Received (Austin, Lake Travis) – 11101 Little</u> Thicket Road

[Engine 301 & Brush 301] Engine 301 was initially dispatched to a light brush alarm on Little Thicket Road. The alarm then changed to a light box alarm and one crew member began getting Tender 301 ready for response. Fire dispatch then changed the address to Hamilton Pool Road and Tender 301 did not self-assign. The address was then changed back to Little Thicket Road. Brush Truck 301 was assigned due to possible better access on Little Thicket Road.

The MDC stated that the homeowner believed there was a fire in the chimney and she deployed a fire extinguisher into the flue from the first floor. On arrival, there was no fire or smoke visible from the exterior other than a minimal amount of smoke escaping the chimney. E301 declared investigation mode. There were no high heat signatures on the exterior of the home along the path of the chimney. Once inside, there was no smoke or high heat signatures along the path of the chimney throughout the home. There was also no smoke or high heat signatures on the second floor. One firefighter entered the attic space and reported no escape of smoke, no fire, no evidence of a prior fire, and no high heat signatures. No fire or smoke had escaped the chimney.

The homeowner described a loud bang and a lot of fire and black smoke coming out of the fireplace. She deployed the extinguisher and then called 911. The fireplace now seemed to be working as intended. The homeowner had recently used the fireplace and did not do anything different when starting the fire. The chimney has been cleaned in the past. It is possible that debris, animals, and/or a bird nest was in the chimney once the fire started, creating a larger amount of fire and black smoke.

Engine 301 stayed on scene a little longer to monitor conditions and nothing changed. All units soon cleared.

[Battalion 302] BAT302 was dispatched to a light brush alarm that was later changed to a structure fire. On arrival, I announced that I didn't see or smell any signs of a fire on the exterior. I asked E301, who was already on scene with E606 on the interior investigating, if they were comfortable cancelling all units not on scene. After they concurred, I cancelled Q51 and E37. All units were cleared after no further signs of fire extension were found.

January 12 (B) – Structure Fire – AutoAid Given (Austin) – 8500 Hanbridge Lane
[Engine 301] E301 was assigned to a 'Structure Fire' in the CoA and arrived at a two-story residential structure with fire showing from the Alpha and Delta sides. E37 was already on scene, in offensive mode, conducting a blitz attack at the Charlie/Delta corner. E301 assumed backup and pulled a rack line from E37 to the front door. E301 met with E37 and determined that E301 would make interior attack through the front door. All ground floor rooms were on fire. E301 knocked down the fires on the ground floor and then made our way upstairs. E301 handed off the nozzle to a crew already upstairs and then exited the structure for new air bottles. While we were changing bottles, Command determined that we were going to go to Defensive mode, and all units were instructed to exit the structure. E301 was then asked by Inside Division to pull a line off of our Engine and take it to the Charlie side and put fire out from the outside. We were then told to move away from the building as an aerial master stream was going to be used.

After the master stream had been shut down, E301 used our previously deployed hoseline to put out hotspots on the Charlie and Bravo sides. After the fire was determined to be out, E301 picked up our hoses and equipment and went to Station 302 for clean bunker gear. We then returned to Station 301, showered, and went back into service.

[Truck 302] TK302 responded code 3 to a structure fire in the City of Austin. While responding, units on scene confirmed that it was an active fire with fire showing from the Alpha and Charlie sides. TK302 was the 3rd red hat unit to arrive and was directed by Command to report to Outside Division to assist. TK302 crew took ladders and hand tools to the scene and made contact with Outside Division. TK302 was directed to work on the Charlie/Delta side. TK302 checked the structure from the exterior and began to put out fire from the exterior of the Delta side. Command changed the mode of operation to Defensive and TK302 crew kept applying water with hoseline to the first and second floor through the windows until directed to pull back while Q51 used the master stream on the aerial. TK302 pulled out and replaced SCBA bottles on packs and was later directed to continue with handlines after aerial operations had stopped. TK302 crew worked on the Delta then Charlie side and was moved to the Bravo side last. Command decided to stop flowing to see if smoke conditions had stopped and then began to clear some units. TK302 was instructed to gather gear and tools and clear off the call. After TK302 had gathered all gear and removed bunker gear, Command called TK302 back to take part in the debrief. After the debrief, TK302 cleared off the call and stayed out of service for decon. TK302 refilled SCBA bottles, refueled TK302, and swapped out bunker gear before going back in service.

[Battalion 302] BAT302 responded to a structure fire in AFD's district. Upon arrival, E37 was on scene and stated they had active fire in the structure and were pulling a rackline to the Charlie side. They said there was fire on the back deck. E301 went on scene and assumed backup. Q51 arrived and they assumed Inside Truck. E29 was the third engine on scene and they got water supply and assumed RIC. E27, BAT302, and BAT08 arrived on scene shortly after. At this time, BAT302 assumed IC and reported back to dispatch of the size up and told them we were in Offensive mode. BAT302 had BAT08 do a 360 and report back. R20 arrived, assumed Outside Truck, and cut utilities to the structure. During this time, E37 said they knocked down the deck fire and were moving interior along with E301 and Q51 because the fire had made it into the structure. BAT302 assigned TK302 to assist R20 with Outside Division and also assigned E27 to do a primary search. BAT302 could not see the structure at the Command Post due to the amount of smoke, but E37 said they had knocked down the fire on the first floor and were moving to the second floor. At this time, BAT302 left the Command Post to get a visual on the structure. I met with BAT08 and the Safety Officer. During our discussion, E37 and E301 were out of air and needed to exit the structure and BAT302 was going to replace them with TK302 and E29. BAT08 told me the garage had flashed and the Safety Officer said the fire was coming out of the windows of the second floor's Bravo, Charlie, and Delta sides. BAT302 decided to do a Tactical Withdraw and go

Defensive. BAT302 told Q51 to put their aerial up and to get ready for Master Stream Operations. After all units exited the structure, BAT 302 asked for PAR and all units were accounted for. We were going to knock down the fire from the exterior and see if we could make entry again, but the fire made it through the roof and inside temperatures exceeded 900 degrees. Also, there was significant fire damage inside the structure along with water damage and we felt it was unsafe to send anyone back in. We stayed in Defensive mode and assigned Divisions. BAT302 assigned Q51, E29, E301, and E37 to the Alpha Division and R20, TK302, and E27 to the Charlie Division. Q51 was able to knock the fire down with the Master Stream on the second floor and the Divisions used handlines to further extinguish the fire from the exterior. BAT302 met with BAT08 and the Safety Officer. Once the fire seemed knocked down and under control, BAT302 transferred Command to BAT08. We began to demobilize some units and had some units stay on scene for mop up. We had a quick debrief with all the units and then BAT302 cleared the scene.

<u>January 17 (A) – Hazardous Condition (Gas Leak) – AutoAid Received (Austin) – 4916</u> Mirador Drive

[Truck 302] TK302 responded code 3 with BAT301 to a hazardous condition with reports of a poly gas line cut with excavator. TK302 arrived on scene with E29 on scene. TK302 had E29 pull a hoseline while TK302 was bunked out with gas monitors and gas clamp. TK302 crew was taken to the area and found the poly line was a 3/4" line with the flow stopped already with the contractors folding the pipe and using wire to secure. No gas was detected in the area until the monitor was placed at the pipe. TK302 secured the pipe with tape and BAT301 notified dispatch and the gas company. TK302 checked the area after using the tape and no detection of flammable gas was found with the monitor. TK302 cleared off the call and returned to service.

[Battalion 301] BAT301 self-assigned to the incident. I arrived at the scene and there was a small excavator that was digging a ditch for some electrical piping for a house addition and hit the residential gas line. TK302 went up to assess the gas line break and found the line was completely torn in half. There was very little gas flowing (probably a flow sensor restrictor valve at the street that shut the line off). E29 arrived and I had them pull a hoseline for protection of the crew that was working in the hole on the gas line. TK302 folded the line on itself and duct taped the ends of the pipe. Texas Gas was notified of what was done. The contractor was told not to work anywhere around the hole until Texas Gas arrived and repaired the line. All crews then cleared the scene and went back into service.

January 18 (B) – Structure Fire – AutoAid Given (Austin) – 6902 Raccoon Run

[Truck 302] TK302 responded code 3 to a box alarm in Austin. While responding, the first unit on scene found a fence, car, and detached garage that were currently burning. E37 reported they had the fire knocked down and would be checking for extension into the detached garage. E37 canceled all other units responding except the next in ladder. TK302 crew was requested by E37 to come to the scene and shut off the power to the detached garage. TK302 found the breaker to the garage on the main house and turned off the power. TK302 checked the exterior and interior of the garage with the TIC for fire extension with none found. TK302 opened all the windows that could be opened in the garage and then E37 cleared TK302 off the call. TK302 cleared off the call and returned to service.

January 20 (B) – Structure Fire – AutoAid Given (Austin) – 6102 Nashua Court

[Truck 302] TK302 responded code 3 to a structure fire in AFD. TK302 arrived on scene with crews in Offensive mode and TK302 went level 1 staging. Command requested TK302 to bring salvage covers to the scene and begin salvage operations. TK302 reported to Inside Division and began to cover furniture on the first floor and remove products that had been burned to the front yard. The fire had been knocked down upon TK302 arrival. TK302 assisted Inside Division with shuttling out the items from the second floor that had been damaged. After all products from the house had been removed, TK302 met outside with Command and crews did a debrief. TK302 cleared off the call after the debrief and returned to service.

January 20 (C) - Structure Fire - AutoAid Given (Austin) - 4309 Triboro Trail

[Truck 302] TK302 was dispatched to a reported box alarm in Austin. TK302 was responding and the first-in unit called out saying there were 2 houses on fire and a second alarm was called for. TK302 arrived on the scene and found 2 houses on fire. The Officer went to the Command Post for an assignment. Command wanted TK302 to wait at the Command Post while having TK302 Officer conduct a hot lap of both houses. After the hot lap was finished, TK302 reported to Command and gave an update and TK302 was then assigned to Bravo Division, which was the house on right from the Alpha side vantage point. The house on the left was Alpha Division. Both houses had fire in the attic and second floor and through the roof on both. TK302 began to work on the Charlie side of the structure and place a 24-foot ladder to the second floor. During our operations, Command called for a tactical withdrawal and had all personnel exit the building. TK302 continued defensive operations looking for fire and checking for extension. Once the fire was knocked down, Command called for all units to transition to Offensive mode. TK302 then began to enter the structure and pull ceiling on the first floor and also search for a cat which was not found. TK302 continued to check for fire in the ceiling. TK302 then exited the structure to replace air bottles and went to rehab. While in rehab, TK302 was then cleared by Command. TK302 then gathered all of our equipment, went to gross decon, and then cleared the scene.

January 24 (B) – Odor Investigation (Short Circuit) – 2716 Barton Creek Blvd #314

[Truck 302] TK302 responded code 1 to an odor investigation. Upon arrival in the complex, TK302 was flagged down by the caller. The caller was outside and complaining of smelling burning plastic. TK302 checked the exterior of the structure with a TIC and nothing was found. TK302 entered the residence with a multi-gas meter and a TIC. The occupants said they smelled it the worst in the living room. TK302 did not notice an obvious odor, but while checking the walls in the living room, an area around a plug showed to be 160+ degrees. TK302 found a burned plugin style scent device. TK302 removed the device and checked the wall area more. The heat did not rise more than approximately 2 feet from the outlet and was an outlet inside the first floor of an exterior wall for a 2-story apartment complex. TK302 asked the occupant if they could take us to the electric panel and the occupant had trouble locating it. While the panel was being located, the heat had dropped to around 140 around the outlet. TK302 checked the panel with no tripped breakers. TK302 crew removed the wall plate to the outlet to find the outlet itself had melted and the wire coatings had melted. TK302 was unable to isolate the breaker to the outlet without turning off all power. The occupant contacted the on-call service for the complex and they said they would arrive in 30 minutes. The heat continued to fluctuate and the odor became stronger, so TK302 carefully loosened the outlet and pulled it out of the wall. After the outlet was pulled away from the wall, TK302 used tools to separate the wires that had the coating melted off. While moving the wires apart, the power went off to multiple lights and outlets in the living room. TK302 checked the electrical panel and found that none of the breakers tripped. TK302 stayed on scene until the temp had lowered below 100 on the outlet box. TK302 verified the occupants knew that the power was still on and to communicate to the technician coming to work on the issue. TK302 cleared off the call and returned to service.

<u>January 31 (B) – Structure Fire – AutoAid Given (Lake Travis) – 809 Brooks Hollow Road</u> [Truck 302] TK302 was called out for a reported box alarm in ESD6. While responding, it was reported as a fire on the exterior of the structure. TK302 was on Hwy 71 and could see heavy black smoke, so we knew then we had a working fire. TK302 arrived on the scene and went to the Command Post for assignment. TK302's crew waited near TK302 until given an assignment. Command then assigned TK302 Charlie Division with E606 assigned. Charlie Division was tasked to access and set up a hoseline to keep working on putting the fire out. Prior to TK302 arriving, Command called for a tactical withdrawal and the fire went Defensive. TK302 and E606 set up a 3-inch line to a ground monitor. We also had power lines down in our Division, so we had to wait for the power to be disconnected. With the monitor set, two members on TK302 climbed a wall with two ladders set on each side to allow crews to access a wall which was at least seven feet high. TK302 broke out a window in our Division to allow us to get a stream of water into the structure. This continued for an hour until Command had all crews go to rehab. Command had Q603 use its master stream. After rehab, we went back to Charlie Division and found more fire that could not get hit by Q603. TK302 setup the ladders and grabbed a 1 3/4" line to hit the fire through a small window and then had E606 get a saw to make a small window a larger single window. We then stretched the line into the area to help extinguish the remaining fire. After about an hour, Command began clearing units. TK302 then gathered our equipment and placed it back on the truck and cleared the scene. TK302 returned to Station 302 for decon and get back in service.
